**Subject: Communication to customers and suppliers of the transfer of Microfusione Stellite Spa's business based in Sasso Marconi (Bologna)**

With this communication we inform all interested persons that, as of March 1 2011, **Microfusione Stellite Spa**, based at its registered office in via G Di Vittorio n° 24 – 20090 Pieve Emanuele (MI), has entered into a purchase and sale agreement ( hereafter the “**agreement**” ) with **ATS Microfound Srl.**, based at its registered office in Via Giovanni Pascoli no. 6 42021 Barco di Bibbiano (RE) Fiscal Code / VAT number 02470230356 in conformity with current legislation.

Under the agreement, Microfusione Stellite Spa ( hereafter the “**Seller**” ) has transferred, with effect from March 1 2011, according to the terms and procedures specified below, a business segment ( the “**business segment**” ) concerned with the production of castings using the lost wax process to ATS Microfound. Srl ( hereafter the “**Buyer**” ).

The business transfer described above has necessitated also the transfer of personal, master file and accounting data ( the “**personal data**” ) contained in documents and in electronic form of all the interested persons, being customers, suppliers and employees who are being transferred ( the “**interested persons**” ).
